Triumph Public High Schools will host a Meet the Teacher Night, and Open House Event. Triumph Public High Schools will have an attendance committee that will meet on an ongoing basis to discuss student attendance rate and possible solutions to assist the student improve attendance. The committee will review student's attendance in addition, discuss the following actions in accordance with school policy: send notice to parent(s)/guardian(s) regarding state requirement of 90% attendance in order to receive course credit; as well as possible withdraw due to attendance falling below the 90% required attendance rate.

4. Provide parent(s)/guardian(s) opportunities to volunteer and participate in their child's class and to observe classroom activities, as well as reasonable access to staff.

Triumph Public High Schools will provide parent(s)/guardian(s) opportunities to volunteer and participate in their child's class and to observe classroom activities. Staff will be available for consultations with parent(s)/guardian(s) during their daily conference periods, and with a scheduled appointment.
